The dividend is payable on January 9, 2025 to shareholders of record as of the close of business on January 2, 2025.

President & CEO Steve Lundgren stated, "We are pleased to announce an increase to the dividend paid to shareholders. The new dividend amount will be \$0.85 per share. Strong Bank performance over several years has allowed Denali Bancorporation to grow its dividend from \$0.15 per share in 2009 to \$0.85 per share currently, a yield of approximately 6.2% per share based on projected December 31, 2024 book value."
